Activity Bucket Mobilization: Grasstops & Grassroots

Utilize Materials to educate & conduct outreach to child care providers, home visitors, community health organizations/workers, grandparent organizations, groups addressing homelessness, those working w/ immigrant & refugee families, etc. to build awareness of the benefits of El and facilitate linkages.

Collect and manage contact information of supporters (sectors listed above) as outreach is conducted in effort to build database for future communication/grassroots advocacy base.

Conduct at least one webinar for the EI, child care provider, and/or home visiting fields on the advocacy campaign's goals and how participants can be engaged.

Conduct at least one webinar for parents with children enrolled in EI on the advocacy campaign's goals and how participants can be engaged.

Mobilize EI providers and parents with children receiving EI services to engage in state budget advocacy.
